SECTION VII · HEALTH AND FIRST AID

PRIMARY ROUTES OF ENTRY & EFFECTS OF OVER EXPOSURE:

Eyes: Can cause severe irritation, redness, tearing and blurred vision.

Skin: Frequent or prolonged contact will cause irritation, defatting of the skin and dermatitis in some cases. May cause allergic skin reaction.

Inhalation: Inhalation of mist can cause irritation of nasal and respiratory passages.
