## 2. Hazards Identification

**Emergency overview** Aerosol. Will be easily ignited by heat, spark or flames. CONTENTS UNDER PRESSURE.

**Potential health effects**

**Eyes** Moderately irritating to the eyes.

**Skin** Harmful if absorbed through the skin.

**Inhalation** Intentional misuse by concentrating and inhaling the product can be harmful or fatal. Harmful if inhaled.

**Ingestion** Exposure by ingestion of an aerosol is unlikely. Ingestion may cause gastrointestinal irritation, nausea, vomiting and diarrhea.

**Target organs** 2-Butoxy ethanol may be absorbed through the skin in toxic amounts if contact is repeated and prolonged and may cause blood damage. These effects have not been observed in humans.  
Kidney. Blood. Central nervous system. Liver. Respiratory system.

**Chronic effects** Conjunctiva. Liver injury may occur. Kidney injury may occur. May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion, and blurred vision) and/or damage. May cause delayed lung damage. Prolonged skin contact may defat the skin and produce dermatitis.

**Signs and symptoms** Corneal damage. Narcosis. Liver enlargement. Conjunctivitis. Defatting of the skin. Irritation.

## 4. First Aid Measures

**First aid procedures**

**Eye contact** Immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention immediately.

**Skin contact** Wash off with warm water and soap. Get medical attention if irritation develops or persists.

**Inhalation** Move to fresh air. Call a physician if symptoms develop or persist.

**Ingestion** Have victim rinse mouth thoroughly with water. Do not induce vomiting without medical advice. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. Do not use mouth-to-mouth method if victim ingested the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device.

### 5. Fire Fighting Measures

#### Extinguishing media

**Suitable extinguishing media** Large Fires: Water spray, fog or regular foam.

Small Fires: Dry chemical, CO<sub>2</sub>, water spray or regular foam.

#### Protection of firefighters

**Protective equipment and precautions for firefighters**

In the event of fire and/or explosion do not breathe fumes. Wear full protective clothing, including helmet, self-contained positive pressure or pressure demand breathing apparatus, protective clothing and face mask. Containers should be cooled with water to prevent vapor pressure build up. For massive fire, use unmanned hose holders or monitor nozzles; if this is impossible, withdraw from area and let fire burn.

### 6. Accidental Release Measures

#### Methods for containment

Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if you can do so without risk. Move the cylinder to a safe and open area if the leak is irreparable.

#### Methods for cleaning up

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean contaminated surface thoroughly.

### 7. Handling and Storage

#### Handling

Pressurized container: Do not pierce or burn, even after use. Do not handle or store near an open flame, heat or other sources of ignition. Do not smoke while using or until sprayed surface is thoroughly dry. Do not use if spray button is missing or defective. Use only with adequate ventilation. Do not get this material in contact with eyes. Do not get this material in contact with skin. Avoid prolonged exposure.
